This includes 63,528 shares of Common Stock subject to options granted under the Company's 1996 Stock Option Plan to which the Reporting Person has the right to acquire beneficial ownership as specified in Rule 13d of the Securities Exchange Act of 1934 and 52,000 shares of Class A Common Stock held by his wife.
