ITEM 1. SECURITY AND ISSUER.

This statement amends and supplements the Schedule 13D dated May 24, 2002, as previously amended by Amendment No.1, dated May 28, 2002, Amendment No. 2, dated February 5, 2002, and Amendment No. 4, dated February 2, 2004, relating to shares of Common Stock, par value \$.01 per share (the "Common Stock"), of DCAP Group, Inc., a Delaware corporation (the "Company"). The address of the principal executive offices of the Company is 1158 Broadway, Hewlett, New York 11557.

All references in this Amendment No. 3 to numbers of shares and per share amounts give retroactive effect to the Company's one-for-five reverse split of its shares of Common Stock effective as of August 26, 2004.

ITEM 2. IDENTITY AND BACKGROUND.

(c) The Reporting Person is employed as the Chief Executive Officer, President, Chairman of the Board, Chief Financial Officer and Treasurer of the Company.

(d) The Reporting Person has not been convicted in a criminal proceeding in the last five years.

(e) The Reporting Person has not, during the last five years, been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction resulting in a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

(f) The Reporting Person is a citizen of the United States of America.

ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION.

ITEM 4. PURPOSE OF TRANSACTION.

Effective December 20, 2004, the Reporting Person exercised options for the purchase of 34,000 shares of Common Stock and received 27,211 shares of Common Stock, net, after the withholding of 6,789 shares in connection with the satisfaction of applicable tax withholding obligations. Effective such date, the Reporting Person also exercised options for the purchase of 160,000 shares of Common Stock and delivered to the Company 27,211 shares in payment of the exercise price.

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER.

As of the date hereof, the Reporting Person is the beneficial owner of 346,400 shares of Common Stock of the Company (or approximately 12.2% of the outstanding Common Stock of the Company). Of such number, 166,000 shares of Common Stock are issuable upon the exercise of options that are exercisable currently or within 60 days, 8,500 shares are held by the Reporting Person's children and 11,900 shares are held by a retirement trust for the benefit of the Reporting Person. The Reporting Person disclaims beneficial ownership of the shares held by his children and retirement trust.

During the past 60 days, except as indicated above, the Reporting Person has not effected any transactions in the Common Stock of the Company.
