- (1) In accordance with the terms of the Merger Agreement entered into by and between Beverly Enterprises, Inc. and Pearl Senior Care, LLC et al. the phantom units deferred under the terms of the Non-Employee Director Deferred Compensation Plan (NEDDCP) vested and converted into common stock.
- (2) In accordance with the terms of the Merger Agreement entered into by and between Beverly Enterprises, Inc. and Pearl Senior Care, LLC et al. the stock held by the Reporting Person were disposed of pursuant to the Merger Agreement.
- (3) This option was fully vested and was cancelled in the merger between Beverly Enterprises, Inc. and Pearl Senior Care, LLC (the "Merger") in exchange for a cash payment representing the difference between the exercise price of the option and the Merger consideration of \$12.50 per share for the underlying common stock.
- (4) Represents the difference between the per share exercise price of the option and the per share merger consideration.
- (5) The option was underwater at the time of merger, therefore, no merger consideration was given for this option to the Reporting Person and the option has been cancelled.
