**Item 1. Security and Issuer.**

This Schedule 13D is filed on behalf of Carl H. Lindner relative to the no par value Common Stock ("Common Stock") issued by American Financial Group, Inc. (referred to herein as "American Financial").

The principal executive offices of American Financial are located at One East Fourth Street, Cincinnati, Ohio 45202.

**Item 2. Identity and Background.**

**Item 3. Source and Amount of Funds or Other Consideration.**

On March 31, 2009, the Reporting Person's spouse transferred 5,000,000 shares of common stock to a trust (for the benefit of the Reporting Person's family) for which a third party serves as trustee with voting and dispositive powers.

**Item 4. Purpose of Transaction.**

The Reporting Person considers his beneficial ownership of American Financial equity securities as an investment which he continues to evaluate. Although he has no present plans to do so, from time to time the Reporting Person may acquire additional American Financial equity securities or dispose of some or all of the American Financial equity securities which he beneficially owns.

Except as set forth in this Item 4, the Reporting Person presently has no plans or proposals that relate to or would result in any of the actions specified in clauses (a) through (j) of Item 4 of Schedule 13D.

**Item 5. Interest in Securities of the Issuer.**

As of April 3, 2009, the Reporting Person beneficially owned 4,345,797 shares (or approximately 3.8% of the outstanding shares) of American Financial Common Stock, which amount includes 369,379 shares held in a charitable foundation over which shares he holds voting and dispositive power.

The Reporting Person does not include as beneficially owned, 7,126,680 shares held in trusts, the grantor of which is his spouse, and the beneficiaries of the trust are Mrs. Lindner and their sons but for which third parties act as trustee with voting and dispositive power.
