The shares underlying the phantom stock units in the director's account will be distributed to the director when he or she ceases to serve as a director of the company.

(5) The Units vest in three equal annual installments beginning on June 15, 2005.

(6) The Units vest in three equal annual installments beginning on June 21, 2006.
