 - (1) The reporting person was granted 32,763 shares of common stock in connection with the settlement of performance-based restricted stock units upon the company's achievement of certain performance criteria for the 2012/2013 period. 50% of the shares vested on the date of grant and the remainder will vest on 3/1/15.

 Represents shares reacquired to satisfy tax withholding obligations in connection with the vesting of (a) 4,687 shares of restricted stock granted to the Reporting Person on 3/1/10 (b) 4,019 shares of restricted stock granted to the Reporting Person on 3/1/11 (c) 13,985 shares of restricted stock granted to the Reporting Person on 3/1/13 as a result of the company's achievement of certain performance criteria for 2011/2012 (the award was originally allocated to the reporting person as performance-based restricted stock units and (d)16,382 shares of restricted stock granted to the Reporting Person on 3/1/14 (see footnote 1).
