MTS announces subscriber growth numbers for September 2007

Moscow, Russian Federation Mobile TeleSystems OJSC (MTS NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that its consolidated subscriber base reached 77.97 million users on September 30, 2007.

During September 2007, MTS consolidated subscriber base increased by 1.91 million subscribers.
