Additionally, PT was informed that, on 19 December 2011, Avistar executed one call option and one put option in respect of 8,000,000 PT shares, with maturity on 9 January 2012. The value of such options is determined in accordance with the market value of the underlying asset.

PT was further informed that Avistar is a person closely related to PT s Non Executive Director Amílcar de Morais Pires, as he is also Chairman of the Board of Directors of Avistar, and therefore this latter has the obligation to notify PT of such transactions pursuant to paragraph 4, b) of article 248-B of the Portuguese Securities Code.

According to information received from BES, after these transactions the voting rights attached to 101,735,760 PT shares, representing 11.35% of PT share capital and corresponding voting rights, were attributed to BES.
