### Long Position

Portugal Telecom, SGPS S.A. ( PT ) informs that it was notified by Barclays Plc that, on 27 April 2012, there was a change in the composition of Barclays Plc's long position in PT due to the expiry of a physically settled equity forward over 7,837,000 PT shares and consequent acquisition of 7,837,000 PT shares. The contract was held and the acquisition was made by Barclays Capital Securities Limited. Barclays Plc's overall long position in PT remained above the 2% threshold of reportable interests as was previously disclosed.
