**Item 1.01. Entry into a Material Definitive Agreement.**

EnLink Midstream, LLC (the Registrant ) indirectly owns the general partner interest, the incentive distribution rights and a portion of the limited partner interests in EnLink Midstream Partners, LP (the Partnership ).

On March 25, 2015, the Partnership entered into an underwriting agreement (the Underwriting Agreement ) with Southwestern Gas Pipeline, L.L.C. (the Selling Unitholder ) and Morgan Stanley & Co. LLC, as representative of the several underwriters named therein (the Underwriters ), with respect to the sale in an underwritten public offering by the Selling Unitholder of 22,800,000 common units representing limited partner interests in the Partnership (the Common Units ) for a price to the public of \$25.71 per Common Unit (the Public Offering ). In addition, the Selling Unitholder has granted the Underwriters a 30-day option to purchase up to an additional 3,420,000 Common Units pursuant to the Underwriting Agreement. The Selling Unitholder is a wholly owned subsidiary of Devon Energy Corporation, which indirectly controls the general partner of the Partnership.

The Public Offering was registered under the Securities Act of 1933, as amended (the Securities Act ), pursuant to a shelf registration statement on Form S-3 (File No. 333-194465) (the Registration Statement ), which became effective automatically upon filing with the Securities and Exchange Commission (the Commission ) on March 10, 2014, as supplemented by the Partnership's prospectus supplement thereto dated March 25, 2015. The closing of the Public Offering is expected to occur on March 30, 2015, subject to customary closing conditions. The Partnership will not receive any proceeds from the sale of the Common Units by the Selling Unitholder in the Public Offering.

In the Underwriting Agreement, the Partnership and the Selling Unitholder agreed to indemnify the Underwriters against certain liabilities, including liabilities under the Securities Act, or to contribute to payments the Underwriters may be required to make because of any of those liabilities.

The foregoing description is qualified in its entirety by reference to the text of the Underwriting Agreement, which is filed as Exhibit 1.1 to this Current Report on Form 8-K (this Current Report ) and incorporated herein by reference.
