### **Explanatory Note**

This Amendment No. 6 to Schedule 13D (this Amendment No. 6 ) amends and supplements the Schedule 13D originally filed with the United States Securities and Exchange Commission (the SEC ) on November 12, 2014 (as amended to date, the Schedule 13D ), relating to the Class A common stock, par value \$0.01 (the Class A shares ) of Pattern Energy Group Inc. (the Issuer ). Capitalized terms used herein without definition shall have the meaning set forth in the Schedule 13D.

Accordingly, each of the foregoing entities may be deemed to share beneficial ownership of the shares held by Pattern Renewables. PEG LP is the sole member of Pattern Finco. As a result, R/C Renewable Energy

Mathias, as the members of the investment committee of R/C Renewable Energy GP II, LLC, may be deemed to share beneficial ownership of the shares beneficially owned by Pattern Renewables. Such individuals expressly disclaim any such beneficial ownership.

Item 5(c) of the Schedule 13D is amended and supplemented by inserting the following information:

From the date of the most recent amendment to this Schedule 13D through April 18, 2018, Pattern Finco disposed of 176,100 Class A shares, in a series of transactions at prices ranging from \$17.36 to \$18.07 per share in open market transactions on the Nasdaq Global Select Market.
