These shares include the following Restricted Stock Units (RSUs) granted under the Company's Amended and Restated 1991 Equity Incentive Plan: 7,500 RSUs which vests in three equal annual installments of 2,500 each commencing 7/31/2009; 1,715 RSUs which vest

(1) in three annual installments of 571 shares on 4/29/2011 and 572 shares on each of 4/29/2010 and 4/29/2012; and 1,257 RSUs which vests in four annual installments of 314 shares on each of 4/28/2010, 4/28/2011 and 4/28/2012 and 315 shares on 4/28/2013. Vested RSUs will be paid in shares of the Company's common stock on a one-to-one basis unless payment is otherwise deferred by the reporting person.

(2) These are shares acquired under the Company's 401(k) Plan and represent interests in the Company's stock fund as of this filing.
