 - (1) On March 2, 2010, four business days following the release of the Company's 2009 Earnings, vesting conditions for 5,004 performance-based RSUs awarded in 2009 were met, resulting in the immediate issuance of an equivalent number of shares of Common Stock which became reportable for Section 16 purposes. Mr. Maynard paid cash for the payroll taxes related to these shares.
 - (2) On March 2, 2010, four business days after the release of the Company's Earnings, vesting conditions for performance-based options awarded March 2, 2009 were met and became reportable for Section 16 purposes. These options are exercisable immediately upon vesting.
 - (3) Includes 57,000 shares held by Mr. Maynard's spouse, and 18,004 shares held jointly with his spouse.
