- (1) On January 31, 2011, 4,213 of Mr. Gerber's previously reported time based restricted shares vested. The company, consistent with its practice, withheld 1,289 shares to satisfy the tax liability associated with the transaction, resulting in Mr. Gerber retaining 2,924 shares of common stock.
- (2) On February 1, 2011 Mr. Gerber exercised 325,000 previously reported stock options which were scheduled to expire on March 14, 2011. The company, consistent with its practice, withheld 193,809 shares to satisfy the tax liability and exercise price associated with these options.
- (3) March 14, 2001 was the grant date of the options. The options vested in three equal tranches, the last of which vested on March 14, 2004.
