(1) Restricted Stock Units (RSUs) granted under the PG&E Corporation 2006 Long-Term Incentive Plan (LTIP). RSUs are payable in shares of PG&E Corporation common stock on a one-for-one basis upon the earliest of one year from the date of grant, a director's death, disability, retirement, or a change in control, as defined in the LTIP.

(2) This total includes 1,144.37 units of phantom stock granted under the PG&E Corporation Non-Employee Director Stock Incentive Plan (SIP), and reflects the acquisition of 11.57 units of phantom stock on 4/15/10, 11.49 units of phantom stock on 7/15/10, 10.78 units of phantom stock on 10/15/10, 10.78 units of phantom stock on 1/18/11, and 11.49 units of phantom stock on 4/15/11, pursuant to a dividend reinvestment feature of the SIP. This total also includes 7,611.60 RSUs granted under the LTIP, and reflects the acquisition of 57.40 RSUs on 4/15/10, 57.05 RSUs on 7/15/10, 53.49 RSUs on 10/15/10, 53.48 RSUs on 1/18/11, and 57.01 RSUs on 4/15/11 pursuant to a dividend reinvestment feature of the LTIP. The phantom stock units and the RSUs are automatically payable in shares of PG&E Corporation common stock only.
