The restricted share units are to be settled in an equal number of common shares of beneficial interest upon vesting. On August 4, 2013 5,000 restricted share units vested and were settled in common shares of beneficial interest, of which 2,600 were sold as described in the preceding footnote and 2,400 are included in the reported amount.
