- (1) On December 21, 2017, Mr. Porges exercised 76,700 previously reported stock options. EQT Corporation, consistent with its practice, withheld 69,135 shares to satisfy the tax liability and exercise price associated with these options.
- (2) January 1, 2011 was the grant date of the options. The options vested in two tranches with 50% vesting on January 1, 2012 and 50% vesting on January 1, 2013. The options would have expired if not exercised on or before December 31, 2017.
