Explanation of Responses:

- (1) The amount of securities shown as beneficially owned by Ms. Quick on Table I have been reduced by 8,734 Restricted Share Units ("RSUs"), which were previously reported on Table I. This Form 4 reflects the previously reported 12/1/14 grant of 8,734 RSUs on Table II.
- (2) Acquisition of RSUs as equity compensation. The date of grant of the RSUs was December 1, 2015. Each RSU represents the right to receive one share of common stock of Meritor, Inc. (the "Company") or its cash equivalent upon the vesting date, which occurs at the earlier of three years from the date of grant or upon termination of employment with the Company under certain circumstances.
- (3) The date of grant of the RSUs was December 1, 2014. Each RSU represents the right to receive one share of common stock of the Company or its cash equivalent upon the vesting date, subject to the terms and conditions described in footnote 2 above.
