(QP), respectively. 1,034,482 shares of Common Stock, 6,206,896 Wts A convertible into 310,345 shares of Common Stock and 2,068,965 Wts B, convertible into 103,448 shares of Common Stock, are held by PE and 317,037 shares of Common Stock, 634,076 Wts A convertible into 31,704 shares of Common Stock and 1,902,225 Wts B, convertible into 95,111 shares of Common Stock, are held by QP.
