Mr. Sussman directly owns common stock of the Issuer. As such, Mr. Sussman received, at no cost from the Issuer, rights to purchase 0.6344 shares of common stock for every share of common stock owned plus rights to subscribe for additional shares up to 20% of the (1) shares of common stock for which he was otherwise entitled to subscribe in the event not all shares of common stock were subscribed for initially. This Form 4 reports the exercise of subscription rights by Mr. Sussman. Receipt of subscription rights was not reported because such receipt is exempt under Rule 16a-9(b).
