Item 8.01 Other Events.

1. On June 23, 2011, we filed a current report on Form 8-K reporting the amendment to our certificate of incorporation to change our corporate name to “Vidable, Inc.” On June 30, 2011, we received notice from FINRA/OTC Corporate Actions that the name change will take effect at the open of business on July 1, 2011. Our new symbol on this date will be “VIBED.OB.” The “D” on our symbol will be removed on July 29, 2011 (20 business days from July 1, 2011).

2. Our Board of Directors approved a 1-for-5,000 reverse stock split of our currently outstanding shares of common stock. The pre-split total shares of common stock outstanding was 1,000,293,791 and post-split total shares of common stock outstanding will be 200,059 (subject to adjustment for settlement of fractional shares, which will be rounded up to the nearest whole share). On June 30, 2011, we received notice from FINRA/OTC Corporate Actions that the reverse stock split will take effect at the open of business on July 1, 2011. Our new symbol on this date will be “VIBED.OB.” The “D” on our symbol will be removed on July 29, 2011 (20 business days from July 1, 2011).
