The Company's revenues for the three and nine month periods ended September 30, 2011 increased to approximately \$36.9 million and \$88.3 million respectively, from approximately \$22.3 million and \$62.8 million in the three and nine month periods ended September 30, 2010, respectively. In addition, net income for the three month period ended September 30, 2011 increased to approximately \$4.5 million from approximately \$3.6 million for the three month period ended September 30, 2010, and decreased to approximately \$11.4 million during the nine month period ended September 30, 2011 from approximately \$12.1 million for the nine month period ended September 30, 2010.
