As at December 16, 2011, Mr. Sciarretta beneficially owned an aggregate of 845,000 shares of the common stock ("Common Stock") of BeesFree Inc. ("Company"). Such beneficial ownership consisted of the ownership by Black Horse Capital LLC, a Florida limited liability company of which Mr. Sciarretta was sole manager, of 770,000 shares of Common Stock, and the ownership of 75,000 shares of Common Stock by Mr. Sciarretta's wife, Kimberley A. Sciarretta. Mr. Sciarretta disclaims beneficial ownership of all the shares of Common Stock owned by his wife. The shares owned by Kimberly A. Sciarretta and by Black Horse Capital LLC were acquired in a privately-held company which merged with the Company as reported and described in the Company's Current Report on Form 8-K, dated December 16, 2011.
