Examples of the potential grant of shares to Mr. Baker under this plan are as follows: 100th percentile rank among peers = maximum award at 200% of target (\$1 million in stock); 60th percentile rank among peers = target award at grant value (\$500,000 in stock); and 50th percentile rank among peers = threshold award at 50% of target (\$250,000 in stock).
