- Mr. Weidemeyer was issued Deferred Stock Units by NRG Energy, Inc. under NRG Energy, Inc.'s Amended and Restated Long Term Incentive Plan on June 2, 2014. Each Deferred Stock Unit was equivalent in value to one share of NRG Energy, Inc.'s Common Stock, (1) par value \$.01 per share. On June 2, 2014, Mr. Weidemeyer received from NRG Energy, Inc. one such share of Common Stock in exchange for each Deferred Stock Unit he was issued on that same date. This amended Form 4 is being filed to include 701 Deferred Stock Units issued to Mr. Weidemeyer on June 2, 2014 that were omitted from the original Form 4.
