- (1) Vesting of restricted stock units ("RSUs") granted to Mr. Akhavan on June 11, 2013.

All of the shares reported as disposed of in this Form 4 were relinquished by Mr. Akhavan and cancelled by Glu in exchange for Glu's agreement to pay federal and state tax withholding obligations of Mr. Akhavan resulting from the vesting of RSUs. Mr. Akhavan did not sell or otherwise dispose of any of the shares reported on this Form 4 for any reason other than to cover required taxes.
