(1) Options granted to the Reporting Person under Maxtor's 1996 Stock Option Plan which were assumed by Seagate on May 19, 2006. This option, which provided for vesting over four years at the rate of 25% on the first anniversary of the grant date, and the remaining shares at the rate of 6.25% quarterly thereafter.

(2) Options granted to the Reporting Person under the Issuer's 2004 Stock Compensation Plan are subject to a four-year vesting schedule. One quarter of the shares will vest on May 22, 2007. The remaining three quarters will vest proportionally annually on May 22 the three years thereafter.
