- (1) The reporting person resigned as a director of the issuer on July 29, 2008. WB Investors LLC's post-resignation sale of 250,000 shares of the issuer's common stock reported herein may be matchable under section 16(b) of the Securities Exchange Act of 1934 to the extent of the reporting person's pro rata ownership interest in WB Investors LLC with the reporting person's purchase of 250,000 shares of the issuer's common stock at prices per share between \$19.87 and \$20 on March 6, 2008. Because the purchase price for such shares exceeded the sales price reported herein, no profit was realized.
- (2) The price in Column 4 is a weighted average price. The actual sales prices ranged from \$4.31 to \$4.67. The reporting person will provide to the issuer, any security holder of the issuer, or the SEC staff, upon request, information regarding the number of shares sold at each price within the range.
- (3) The reporting person is the managing member of WB Investors LLC and exercises voting and investment power over the shares beneficially owned by WB Investors LLC.
