Each share of Class B Common Stock is convertible at any time, at the option of the holder, into one share of common stock.

Stack Grantor Retained Annuity Trusts referenced in footnotes 4 through 8 below, and were transferred to Edward W. Stack on September 7, 2011 to satisfy annuity payment obligations under each of the Grantor Retained Annuity Trusts.
