Twenty-five percent (25%) of the grant vests on the first anniversary of the date of grant and thereafter as to twenty-five percent (25%) of the granted RSU on each subsequent annual anniversary date of the date of grant, subject to necessary withholding for applicable taxes.
- (2) On April 20, 2015, Reporting Person was awarded restricted stock units (RSUs). Each RSU represents a contingent right to receive one (1) share of VeriSign common stock once vested. Twenty-five percent (25%) of the grant vests on June 30, 2015, and will vest thereafter as to an additional twenty-five percent (25%) of the grant on each of April 20, 2016, April 20, 2017 and April 20, 2018, subject to necessary withholding for applicable taxes.
