Voting Rights and Capital

In conformity with Rule 5.6 of the FSA's Disclosure and Transparency Rules:-

The total issued share capital of Smith & Nephew plc at 30 November 2010 comprised 952,129,395 ordinary shares of US20¢ each, including 62,747,255 ordinary shares held in treasury.

The Company's issued share capital, with one voting right per share, therefore consists of 888,949,540 ordinary shares of US20¢ each.
