**NARRATIVE**

State below in reasonable detail the reasons why Forms 10-K, 20-F, 11-K, 10-Q, N-SAR, N-CSR, or the transition report portion thereof, could not be filed within the prescribed time period.

As previously disclosed, on May 8, 2006, Silicon Graphics, Inc. (the Company) and certain of its subsidiaries (collectively, the Debtors), filed voluntary petitions for reorganization under Chapter 11 of Title 11 of the United States Code (the Bankruptcy Code) in the United States Bankruptcy Court for the Southern District of New York (the Court) (Case Nos. 06-10977 (BRL) through 06-10990 (BRL)). The Company is also currently in the process of assessing its long-lived assets for potential impairment. In addition, in June 2006, the Company announced that it had dismissed Ernst & Young as its independent registered public accounting firm and retained KPMG LLP as its new independent registered public accounting firm.

As a result of these events, the Company requires additional time to update the filing to reflect its current situation as well as to finalize its audited financial statements and related internal control assessment for the year ended June 30, 2006. Accordingly, the Company is unable to file its Annual Report on Form 10-K for the period ended June 30, 2006 within the prescribed time period without unreasonable effort or expense. The Company expects that it will file the Form 10-K as soon as practicable and that the financial statements included in such filing will reflect any potential adjustments that may be required as the result of an asset impairment evaluation as well as any other necessary adjustments and/or disclosures that must be included in order for such financial statements to be stated in accordance with U.S. generally accepted accounting principles.

The Company cannot currently give a reasonable estimate of its results for the fiscal year ended June 30, 2006 due to potential adjustments that may be required as the result of an ongoing asset impairment evaluation as well as any other necessary adjustments and/or disclosures that must be included in order for such financial statements to be stated in accordance with U.S. generally accepted accounting principles.

Factors that might cause such a difference in results include, but are not limited to: the effects of our chapter 11 filing; our ability to maintain adequate liquidity; our ability to obtain and maintain normal terms with customers, suppliers and service providers; our ability to continue as a going concern; our ability to operate pursuant to the terms of our credit agreement; our ability to obtain Court approval and any other required approvals with respect to motions in the chapter 11 case prosecuted by us from time to time; our ability to develop, prosecute, confirm and consummate one or more plans of reorganization with respect to our chapter 11 case; risks associated with third parties seeking and obtaining Court approval to either terminate or shorten the exclusivity period and confirm one or more plans of reorganization; risks associated with third parties seeking and obtaining Court approval to appoint a chapter 11 trustee; risks, although not likely, associated with the case being converted to one under chapter 7; our ability to maintain contracts that are critical to our operation; our ability to conclude our exploration of strategic alternatives; risks associated with the volatility of our stock price; risks associated with the timely development, production and acceptance of new products and services; increased competition; dependence on third party partners and suppliers; the failure to achieve expected product mix and revenue levels; failure to manage costs and generate improved operating results and cash flows; failure to maintain compliance with debt covenants; and failure to maintain adequate cash resources for the operation of the business. Additionally, due to material uncertainties, it is not possible to predict the length of time we will operate under chapter 11 protection, the outcome of the proceeding in general, whether we will continue to operate under our current organizational structure, or the effect of the proceeding on our businesses and the interests of various creditors and security holders.

The Company undertakes no duty to update any statement in light of new information or future events.
