**Item 8.01 Other Events.**

On April 14, 2008, Virginia Electric and Power Company (the Company) entered into an underwriting agreement (the Underwriting Agreement) with Barclays Capital Inc.; Greenwich Capital Markets, Inc. and Wachovia Capital Markets, LLC, as Representatives for the underwriters named in the Underwriting Agreement, for the sale of \$600,000,000 aggregate principal amount of the Company's 2008 Series A 5.40% Senior Notes due 2018. Such Senior Notes, which are designated the 2008 Series A 5.40% Senior Notes due 2018 are Senior Debt Securities that were registered by the Company pursuant to a registration statement on Form S-3 under Rule 415 under the Securities Act of 1933, as amended, which registration statement became effective on January 9, 2006 (File No. 333-130932). A copy of the Underwriting Agreement including exhibits thereto, is filed as Exhibit 1.1 to this Form 8-K.

The form of the Eighteenth Supplemental Indenture to the Company's June 1, 1998 Senior Indenture, pursuant to which the 2008 Series A 5.40% Senior Notes due 2018 will be issued, is filed as Exhibit 4.2 to this Form 8-K.
