The Board of the Company is pleased to announce that the proposed special resolution was duly passed by shareholders by way of poll at the EGM of the Company held on 12 March 2009.

**Results of the EGM**

The Board of China Telecom Corporation Limited (the Company) is pleased to announce that the proposed special resolution was duly passed by shareholders by way of poll at the extraordinary general meeting (the EGM) of the Company held on 12 March 2009 at No. 31 Jinrong Street, Xicheng District, Beijing, PRC.

As of the date of the EGM, the total number of issued shares of the Company was 80,932,368,321, which was the total number of shares entitling the holders to attend and vote for or against the special resolution. There were no restrictions on any shareholders casting votes on the proposed special resolution at the EGM. The EGM was held in compliance with the requirements of the Company Law of the People's Republic of China and the provisions of the articles of association of the Company.
