**EXPLANATORY NOTE**

Knight Capital Group, Inc., a Delaware corporation (the Registrant ), is filing this Post-Effective Amendment No. 1 to Form S-8 Registration Statement to deregister certain securities originally registered by the Registrant pursuant to the Registration Statement on Form S-8 filed with the Securities and Exchange Commission (the Commission ) on January 9, 2007 (Registration No. 333-139879) (the 2007 Registration Statement ), pursuant to which the Registrant registered 8,000,000 shares of the Registrant's Class A common stock, \$0.01 par value per share (the Common Stock ) for issuance pursuant to the Knight Capital Group, Inc. 2006 Equity Incentive Plan (the 2006 Plan ).

On May 12, 2010, at the 2010 Annual Meeting of Stockholders of the Registrant, the Registrant's stockholders approved the Knight Capital Group, Inc. 2010 Equity Incentive Plan (the 2010 Plan ), which the Registrant's Board of Directors had previously approved, subject to such stockholder approval. The 2010 Plan provides, among other things, that a maximum of 10,580,044 shares of Common Stock is reserved for issuance under the 2010 Plan (subject to equitable adjustment in the event of a change in the Registrant's capitalization), which includes 541,703 shares of the Registrant's Common Stock that are authorized to be issued under the 2006 Plan and that, as of April 1, 2010, have not been issued and are not subject to outstanding awards granted under the 2006 Plan (the Unused 2006 Plan Shares ). Upon stockholder approval of the 2010 Plan, the 2010 Plan replaced the 2006 Plan and certain other of the Registrant's equity-based compensation plans and no additional awards will be made under the 2006 Plan or such other plans. Therefore, in accordance with the undertaking contained in the 2007 Registration Statement, the Unused 2006 Plan Shares, which were previously registered under the 2007 Registration Statement, but not issued under the 2006 Plan, are hereby deregistered. The 2007 Registration Statement will remain in effect, however, to cover the potential issuance of shares of Common Stock pursuant to outstanding awards granted under the 2006 Plan prior to April 1, 2010.

The Registrant is concurrently filing a separate Registration Statement on Form S-8 to register 10,580,044 shares of Common Stock for offer or sale pursuant to the 2010 Plan, including the Unused 2006 Plan Shares and the unused shares from the Registrant's other equity-based compensation plans replaced by the 2010 Plan.
