**The following letter was sent by Constellation Energy to shareholders on October 28, 2011.**

Dear Fellow Stockholder:

We have previously sent to you proxy material for the important special meeting of Constellation stockholders, to be held on November 17, 2011, regarding the proposed merger with Exelon Corporation. **Your board of directors unanimously recommends that stockholders vote FOR all the proposals under consideration.**

As more fully described in the proxy statement, we expect the merger to create one of the leading competitive energy businesses by size, with a stronger and larger balance sheet than Constellation has alone and a more diversified energy delivery, business mix and generation portfolio and customer base. Constellation stockholders, as stockholders of the combined company, will be able to benefit from future growth of the combined company. Based on the current levels of the dividend paid on the Exelon common stock, which is expected to be maintained following the merger, the merger is expected to result in an increased dividend rate for Constellation's stockholders.
