On November 11, 2011, the following message regarding voting on the proposed merger was included in an email sent to employees of Exelon Business Services Company:

I d like to take the opportunity to remind you to participate in three very important efforts. The first is the proxy vote related to our pending merger with Constellation. Those of you who hold shares in Exelon should have received one or more proxy cards in the mail. The Exelon Board of Directors recommends a vote FOR the two merger proposals in the proxy, and it is very important that we each vote our shares. You will need to record votes for each proxy card you receive; clear instructions for voting on the web, by phone or by mail are printed on each card. The deadline is November 16, in advance of the Special Meeting of Shareholders to be held the next day.
