NTT DOCOMO, INC (the Company) hereby announces that on Friday, May 10, 2013, the Board of Directors decided to submit a proposal on Partial Amendments to the Articles of Incorporation, which includes the change of the company's Japanese name, to the 10<sup>th</sup> Ordinary General Meeting of Shareholders to be held on Tuesday, June 18, 2013.

1. Change of the Company's Name

(1) Reason for the company name change

To unify the company name for Kabushiki Kaisha NTT DOCOMO which is currently used as a common name.

(2) The current and new company name (in Japanese only)

Current : Kabushiki Kaisha N.T.T. DOCOMO  
New : Kabushiki Kaisha NTT DOCOMO
