**Item 5.02. Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers**

(a) On July 15, 2013, Robert Muffly resigned from the Board of Directors of Gold Resource Corporation (the Company) effective immediately. A copy of the resignation letter provided by Mr. Muffly to the Company is attached as an exhibit to this report. Mr. Muffly's resignation was triggered by certain events described in the Strategic Alliance Agreement dated December 5, 2008 between the Company and Hochschild Mining Holdings Ltd. (Hochschild). Pursuant to the terms of the Strategic Alliance Agreement, the director nominated by Hochschild shall automatically resign following Hochschild's disposition of more than 20% of its pro rata ownership interest in the Company. Mr. Muffly was nominated by Hochschild at the Company's annual meeting of shareholders held on June 20, 2013 and has served on the Board of Directors since that time. Mr. Muffly is not resigning on account of any disagreement with the Company on any matter relating to its operations, policies or practices.
