Anthem President and Chief Executive Officer, Joseph Swedish, made the following comments about the pending Cigna transaction today at the 2015 Credit Suisse Annual Health Care Conference:

This acquisition combines complementary platforms in a way that uniquely benefits customers while also driving meaningful shareholder value.

Cigna brings a number of strengths which will enhance our ability to serve our growing membership base, including strong technology platforms, highly regarded wellness programs, and strong client reporting capabilities. Exposure to key Medicare growth geographies, substantial experience with a unique set of international product offerings, stop loss ASO products and clinical programs, and, finally, specialty capabilities that address customer requests for dental, vision, behavioral and disability and life offerings.

This acquisition will also advance the three pillars [of our focus: provider collaboration, managing total cost of care and focusing on consumer centricity]. We recognize Cigna will enhance our ability to collaborate with providers.

They bring an additional focus on provider engagement, care coordination and connected care, including incentive alignment to optimize relationships that connect care between customers and providers to drive better health, experience and long-term affordability. We also believe Cigna will enhance our ability to manage the total cost of care, and they have substantial expertise in specialty programs, including behavioral health, dental, pharmacy, and disability and life, in addition to its well-regarded disease management and wellness programs.

Finally, we will leverage Cigna's focus on personalization and leveraging insights to advance our goal to deliver valued experiences to our customers, which is reinforced by products and services that meet the needs of various consumer segments. Taken together, while we are very focused on improving our capabilities on a standalone basis, we expect Cigna acquisition to meaningful[ly] advance our mission and capability to improve affordability and choice to our customers and also create a higher quality-performing portfolio.

We continue to remain disciplined in deploying our capital. Our first priority is always to invest in our business. Our second priority is to use capital to pursue M&A opportunities, as evidenced by our recent announcement to acquire Cigna. M&A is part of our long-term strategy to improve affordability for our customers, offer additional choices to the market, and/or improve our core capabilities.

After the first two priorities are satisfied, we continue to remain committed to returning capital to our shareholders. We reiterated our commitment to maintaining our dividend as we work through integrating the Cigna transaction, and share buybacks will remain an important part of our capital deployment strategy. While we have suspended share repurchase for the remainder of 2015, we do expect to resume our share repurchase program in 2016, subject to market conditions, albeit at a lower level than in recent years.
