## **Item 1.01 Entry into a Material Definitive Agreement**

On September 16, 2016, Dover Motorsports, Inc. and its wholly owned subsidiaries Dover International Speedway, Inc. and Nashville Speedway, USA, Inc., (collectively, the Borrowers), modified its secured credit agreement with its bank group. The credit facility was modified to: extend the maturity date to July 31, 2020; release the mortgage and security interest in the collateral securing the agreement; and redefine certain terms within the agreement.
