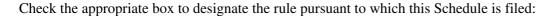

As such, GIC has the sole power to vote and power to dispose of the 12,172,629 securities beneficially owned by it. GIC shares power to vote and dispose of 3,321,527 securities beneficially owned by it with MAS.
