- (1) Includes shares for restricted stock grants as follows: 12,750 vest on 11/1/2009, 22,500 vest on 1/3/2010, and 12,750 vest on 11/1/2011.
The number of underlying securities is based on the stock fund balance on September 30, 2009. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a September 30, 2009, stock fund price of \$25.56 per share, and includes a company match of 522.33 shares on 4/1/2009.
- (2) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. Shares of phantom stock are payable in cash following the reporting person's termination of employment with the company and may be transferred by the reporting person into an alternative investment account at any time.
- (3) The phantom stock units were accrued under the Johnson Controls Retirement Restoration Plan and are to be settled 100% in cash upon the reporting person's termination of employment with the company.
- (4) Includes 256.737 phantom stock units acquired through reinvestment of dividends on October 2, 2008, January 5, April 2, July 2, and October 2, 2009, at prices ranging from \$15.02 to \$27.18 per phantom stock unit.
Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. The restricted stock units were accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash upon the vesting of the reporting person's Restricted Stock.
- (5) Includes 1,592.991 phantom stock units acquired through reinvestment of dividends on October 2, 2008, January 5, April 2, July 2, and October 2, 2009, at prices ranging from \$15.02 to \$27.18 per phantom stock unit.
