(1) This amended Form 4 is being filed to provide information that was omitted from the original filing due to a technical complication. The original Form 4 filed on December 22, 2006 was to include two separate purchases of shares: 5,000 shares on December 21 and 4,300 shares on December 22. Although the December 21 transaction line item was included in the electronic transmission, the Form 4 as filed with the SEC did not include this transaction line item. However, the number of shares purchased on December 21, 2006 was included in the original filing in the aggregate number of shares beneficially owned after the transactions. The total amount of securities beneficially owned as of December 22, 2006 in the amount of 219,300 was accurate as filed on December 22, 2006 and reflected both transactions.
