- (1) The reported transaction involves an award of restricted stock under the M&T Bank Corporation 2005 Incentive Compensation Plan. The restricted stock award includes a total of 3,493 shares. 349 shares of the restricted stock award will vest on January 31, 2009; an additional 698 shares will vest on January 31, 2010; an additional 1,047 shares will vest on January 31, 2011; and the remaining 1,399 shares will vest on January 31, 2012.
- (3) The restricted stock award was granted under an incentive compensation plan maintained by M&T Bank Corporation, and therefore the reporting person paid no price for the shares.
- (4) The option granted includes a total of 26,814 shares. 2,681 of the covered shares are exercisable on or after January 31, 2009; an additional 5,363 of the covered shares are exercisable on or after January 31, 2010; an additional 8,044 of the covered shares are exercisable on or after January 31, 2011; and the remaining 10,726 covered shares are exercisable on or after January 31, 2012.
- (5) The option was granted under an incentive compensation plan maintained by M&T Bank Corporation, and therefore the reporting person paid no price for the option.
