- (1) Common Stock Equivalent Units awarded on 3/25/09 under the Company's Performance Recognition Plan (the "PRP") and the Company's 2008 Performance Plan (the "Plan"), the payment of which has been deferred. Each unit accrues dividend equivalents (on each dividend payment date in an amount equal to the per share cash dividend paid), if any, until paid.
 - (2) The reporting person elected to defer a portion of his 2008 PRP award as deferred Common Stock Equivalent Units under the Plan. Each unit is equivalent in value to the fair market value of one (1) share of common stock.
 - (3) The units will be paid in shares of common stock after 12/31/2011. 4,742.86 of the units will vest on 3/25/2010, and 23,714.28 of the units are fully vested on the date hereof.
 - (4) The units were initially valued at \$5.25, the fair market value on 2/25/09 (the date the deferral election was approved by the Compensation Committee of the Board of Directors).
