- (1) Represents restricted stock units which vest in four equal annual installments beginning on August 7, 2017, subject to continued employment. Vesting will also accelerate in certain circumstances if there is a change in control of the Issuer.
Each performance restricted stock unit ("PRSU") represents a contingent right to receive one share of Issuer common stock. PRSUs vest upon the achievement of adjusted EBITDA and compounded annual revenue growth rate goals for the two year period ending December 31, 2017. Vesting of the PRSUs will accelerate upon death or disability in an amount equal to the proportion of days in the performance period worked. Vesting will also accelerate in certain circumstances if there is a change in control of the Issuer during the performance period.
