(2) These restricted stock units are subject to performance-based vesting conditions based on the company's actual results compared to financial objectives established under the long-term incentive compensation plan, and vest 100% on May 23, 2021, subject to achievement of the performance-based vesting conditions.

(3) These restricted stock units vest 33 1/3% on each of May 23, 2019, May 23, 2020 and May 23, 2021.
