- (3) 20% vests on first anniversary of grant date; 5% vests each anniversary quarter thereafter.
- (4) Shares acquired upon vesting of performance based RSUs. Each vested RSU converts into 200% of one share of McGrath RentCorp common stock.

- (5) The RSUs vest 60% at the end of the three-year performance period if the performance goal is satisfied; then 20% vests each anniversary thereafter. The conversion price of the RSUs was based on the closing price of McGrath RentCorp common stock on March 2, 2015 and therefore such date is determined to be the date exercisable.
- (6) Forfeiture of performance based RSUs awarded on 3/2/2012.
