(2) The shares vest over a 24 month period beginning on February 1, 2007 based on the achievement of revenue growth performance by the issuer relative to the Semiconductor Industry Average annual growth rate as assessed by the Compensation Committee during such period. The reporting person may vest as to a minimum of no shares or up to a maximum of 20,000 shares annually; provided that in no event shall the reporting person vest in an aggregate of more than 20,000 shares.
